WHEREAS, funding is available for Fiscal Year (FY) 2023-2024 Recommended Operating Budget, page 75, I010 FN024024 Fleet Services Parts.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The City Manager or his designee is hereby authorized to extend the Agreement and to enter into any written agreement extending the term of the Integrated Supply Agreement by and Between Genuine Parts Company and City of Des Moines, Iowa d/b/a NAPA Auto Parts Agreement until December 31, 2025.
