SET HEARING FOR APPROVAL OF A LICENSE AGREEMENT WITH CAPITAL CITY PRIDE-DES MOINES FOR USE OF A PORTION OF STREET RIGHT-OF-WAY AT EAST GRAND AVENUE AND EAST 5TH STREET FOR A TEMPORARY ART INSTALLATION

WHEREAS, the City of Des Moines ("CITY") is the titleholder of certain street right-of-way ("Licensed Premises") located at East Grand Avenue and East 5th Street; and

WHEREAS, Capital City Pride-Des Moines, an Iowa non-profit corporation, wishes to license the Licensed Premises for the purpose of installing and displaying a temporary art project consisting of painted sidewalks tentatively titled "Pride Sidewalks, which concept has been approved by the Public Art Foundation of Greater Des Moines; and

WHEREAS, the CITY has negotiated a Temporary License Agreement ("Agreement") with Capital City Pride-Des Moines to allow for installation and display of the temporary art project, which Agreement will include, among other terms, the following:

- A fixed term from May 7, 2024 until September 30, 2025;
- The right of either party to terminate the Agreement prior to the end of the fixed license term, with or without cause, upon thirty (30) days written notice to the other party; and

WHEREAS, there is no known current or future public need or benefit for the Property proposed to be licensed, and the City will not be inconvenienced by the license of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to license a portion of the street right-of-way at East Grand Avenue and East 5th Street, legally described as follows, subject to the reservation of easements therein, and further subject to all terms and conditions contained in the License Agreement:
