APPROVING RENTAL OF CRAFCO WIDE CRACK SEALER AND PURCHASE OF SEALANT MATERIAL FROM LOGAN CONTRACTORS SUPPLY IN THE AMOUNTS OF \$46,452.00 FOR RENTAL AND \$107,100.00 FOR MATERIAL FOR A TOTAL AMOUNT OF \$153,552.00

WHEREAS, the Public Works Department, Street Maintenance Division has requested the Finance Department, Procurement Division to undertake the rental of a Crafco Wide Crack Sealer for seven (7) months and to purchase 126,000 pounds of sealant material to repair wide joints on concrete paved streets; and

WHEREAS the Procurement Administrator has determined that the rental of a Crafco wide crack sealer and purchase of sealant material for said repairs is available from Logan Contractors Supply, 4101 106th Street, Urbandale, IA 50322, Bruce Logan, President, the sole area-wide provider; and

WHEREAS, Des Moines Municipal Code Section 2-726(d) provides for a noncompetitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing City needs, materials or equipment to be cost-effective; and

WHEREAS, funding for said procurement is available from S360 PW240402, Public Works, Street Maintenance, Road Use Tax Fund.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines hereby approves the sole source procurement of a Crafco wide crack sealer rental and sealant material from Logan Contractors Supply for the above-described repair of wide joints on concrete paved streets at a total cost of \$153,552.00 and directs the Finance Department, Procurement Division to issue a purchase order for said rental and material.
