APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE BIDDING REQUIREMENT FOR GOOD CAUSE, APPROVING THE PROCUREMENT OF MAINTENANCE AND SERVICE FOR CITY WEBSITE FROM REVIZE, LLC, AND APPROVING NEGOTIATION AND EXECUTION OF AN AGREEMENT WITH REVIZE, LLC

WHEREAS, the City's Public Information Office desires to procure website service and maintenance services, including hosted content management software, to operate, maintain, and support the City of Des Moines website; and

WHEREAS, on November 30, 2017, the Procurement Division issued a Request for Proposals (V18-029) for Website Redevelopment Design and Implementation (RFP) and received six proposals in response, with Revize LLC a/k/a Revize recommended as the best proposal; and

WHEREAS, on April 23, 2018, by Roll Call No. 18-0725, the City Council accepted the proposal submitted by Revize and authorized the City Manager to execute a contract for the provision of such services, which contract was executed on or around July 25, 2018; and

WHEREAS, both parties wish to continue the hosting and maintenance of the City's website and software services provided by Revize for an anticipated four-year term with the option for one additional four-year renewal period; and

WHEREAS, funding in the amount of \$29,500.00 annually is available from CM023000-521020; and

WHEREAS, the City Manager and the Chief Communications Officer recommend that the above-described procurement be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Des Moines Municipal Code; and

WHEREAS, said procurement will require an agreement between the City and Revize with terms specific to the City's procurement, with said agreement to be negotiated by the City's Procurement Division and Public Information Office.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa:

1. That good cause has been shown to exempt the procurement of website service and maintenance services, including hosted content management software from the Procurement Ordinance competitive request for proposals process.
2. The purchase of website service and maintenance services, including hosted content management software, from Revize, LLC a/k/a Revize for use by the Communications Office, in the amount of \$29,500.00 annually, is hereby approved.
