BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer, showing the cost of the construction of the Animal Control Facility Bid Package No. 14 – Mechanical, Activity ID 102022015, in accordance with the contract approved between A J Allen Mechanical Contractors, Inc., Mark W. Allen, President, 320 S.E. 6th Street, Des Moines, IA, 50309, under Roll Call No. 22-0482, of March 21, 2022, and the City of Des Moines, and recommending the acceptance thereof, be and the same is hereby approved, and accepted.

BE IT FURTHER RESOLVED: That \$3,597,196.65 is the total cost, of which \$3,489,280.75 has been paid the Contractor, and \$0.00 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$107,915.90 is to be paid at the end of thirty days, with funds retained for unresolved claims on file in accordance with Iowa Code Chapter 573.
