APPROVING NEGOTIATION OF AGREEMENT WITH IH MISSISSIPPI VALLEY CREDIT UNION FOR CITY OF DES MOINES POOL PASS PROGRAM

WHEREAS, the City of Des Moines Parks and Recreation Department has received a request from IH Mississippi Valley Credit Union ("IHMVCU") whereby IHMVCU would purchase youth and adult pool punch card passes for distribution to their Des Moines-area credit union members upon proof of purchase of identical pass(es) by said members; and

WHEREAS, said passes would not be for resale by IHMVCU and the full value of the pool passes would be paid upfront by IHMVCU to the City, with refund issued solely for wholly unused pool passes physically returned to the City at the end of the aquatic season; and

WHEREAS, Parks and Recreation Department staff wish to negotiate an agreement with IH Mississippi Valley Credit Union setting forth the terms of the purchase and program for an initial one-year term with successive one-year renewals, subject to approval as to form by the Legal Department, and may wish to pursue similar partnerships in future years as part of a City pool pass program if this partnership proves to be successful for the City during summer 2024; and

WHEREAS, the City Council recognizes that such programming will be beneficial to the residents of the City of Des Moines and to the Parks and Recreation Department.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The Parks and Recreation Department is authorized and directed to negotiate an agreement between the City of Des Moines and IH Mississippi Valley Credit Union, and the City Parks and Recreation Department Director is authorized to execute and administer the agreement on behalf of the City, following approval as to form by the Legal Department.
2. The City Parks and Recreation Department Director is authorized to consider, approve, and execute future similar agreements for a City pool pass program, following approval as to form by the Legal Department, and the Director and his designee(s) are directed to administer the agreement(s) on behalf of the City.
