## RESOLUTION APPROVING THE PURCHASE OF ONE (1) ADDITIONAL TRACKED EXCAVATOR FROM ZIEGLER CAT INC., AND APPROVING USE OF SOURCEWELL CONTRACT NUMBER 032119-CAT

**WHEREAS**, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for one (1) additional tracked excavator for use by the Street Maintenance Division of the Department of Public Works; and

**WHEREAS**, the Procurement Administrator has determined that the tracked excavator has been competitively bid and is available from Ziegler CAT Inc., 1500 Ziegler Drive, Altoona, IA 50009, William Hoeft, (President) using Sourcewell Contract Number 032119-CAT; and

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the tracked excavator is being purchased from Ziegler CAT Inc., in the amount of \$188,444.67 utilizing the Sourcewell Contract Number 032119-CAT; and

**WHEREAS**, funding is available from 2023-2024 Operating Budget, Equipment Replacement Fund, Page 8.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

- 1. The purchase of one (1) additional tracked excavator for use by the Street Maintenance Division of the Department of Public Works from Ziegler CAT Inc., in the amount of \$188,444.67 utilizing the Sourcewell Contract Number 032119-CAT is hereby approved.
- 2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Fleet Division are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City of Des Moines and Ziegler Cat Inc., supplementing Sourcewell Contract No. 032119-CAT, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
