WHEREAS, on May 20, 2024, under Roll Call No. 24-0719, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Twana Drive Reconstruction from West of 48th Street to East of 50th Street, Activity ID 062024009

The improvement includes furnishing labor, equipment and materials for the removal of existing Portland Cement Concrete (PCC) pavement, prepare subgrade/subbase, construct new pavement with seven (7) inches of Roller Compacted Concrete (RCC), and replace sections of Portland Cement Concrete (PCC) curb and gutter, all in accordance with the contract documents along Twana Drive from west of 48th Street to east of 50th Street and other locations as directed by the City Engineer

which were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on June 04, 2024. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Synergy Contracting, LLC, Jesse Rognes, President, 7481 US HWY 65/69, Des Moines, IA, 50320 in the amount of \$131,139, and said bid be and the same is hereby accepted.
