RESOLUTION HOLDING HEARING ON CITY-INITIATED REQUEST TO RENAME TWO (2) CUL-DE-SAC STREET SEGMENTS OF CAULDER COURT TO EAST CAULDER COURT

WHEREAS, on July 15, 2024, by Roll Call No. 24-0962, the City Council received a communication from the City Plan and Zoning Commission advising that at a public hearing held on June 20, 2024, its members voted 11-0 in support of a motion to recommend **APPROVAL** of a City-initiated request to add the “East” prefix to the name of two (2) “Caulder Court” cul-de-sac street segments, thereby renaming both “East Caulder Court”; the cul-de-sacs are located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south; and

WHEREAS, on July 15, 2024, by Roll Call No. 24-0962, it was duly resolved by the City Council that the proposal to rename two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south, to “East Caulder Court” be set down for hearing on August 5, 2024 at 5:00 p.m. in the Council Chambers at City Hall; and

WHEREAS, due notice of said hearing was published in the Des Moines Register, as provided by law, setting forth the time and place for hearing on said proposed street renaming; and

WHEREAS, in accordance with said notice, those interested in said proposed street renaming, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts, and any and all statements of interested persons and arguments of counsel, any objections to the proposed renaming of two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south, to “East Caulder Court” are hereby overruled, and the hearing is closed.
2. The proposed renaming of two (2) “Caulder Court” cul-de-sac street segments, located to the west and southeast of Southeast 23rd Street between East Park Avenue to the north and Evergreen Avenue to the south, to “East Caulder Court” is hereby approved, subject to final passage of the appropriate ordinance.
