
The Birdland Pool Facility Reroofing includes the demolition of the existing roofing materials, removal and replacement of all rooftop equipment and demolition of the existing coping and skylights, installation of a new thermoplastic polyolefin (TPO) roofing membrane with all proper flashing, coping, insulation crickets, boots and trim, and new skylights, all in accordance with the contract documents including Plan File No. 668-202/209, located at Birdland Pool Facility, 300 Holcomb Avenue, Des Moines, Iowa
