RESOLUTION SETTING PUBLIC HEARING REGARDING REQUEST FROM DELANEY ENTERPRISES, LLC (OWNER), REPRESENTED BY CONNOR DELANEY (OFFICER), TO REZONE THE PROPERTY LOCATED AT 515 EUCLID AVENUE FROM "MX1" MIXED USE DISTRICT TO "MX2" MIXED USE DISTRICT, TO ALLOW AN EXISTING BUILDING TO BE USED FOR AN "EATING AND DRINKING PLACES – BAR" USE

WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on August 1, 2024, its members voted 11-0 in support of a motion to recommend APPROVAL of a request from Delaney Enterprises, LLC (Owner), represented by Connor Delaney (Officer), for the property located at 515 Euclid Avenue, to rezone the property from "MX1" Mixed Use District to "MX2" Mixed Use District, to allow an existing building to be used for an "Eating and Drinking Places – Bar" use and determined the requested rezoning is in conformance with the PlanDSM: Creating Our Tomorrow Comprehensive Plan; and

WHEREAS, the Property is legally described as follows:

THE WEST 24 FEET OF LOT 12, BLOCK 22, HIGHLAND PARK, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA.

**NOW, THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the attached communication from the Plan and Zoning Commission is hereby received and filed.
- 2. That the meeting of the City Council at which the proposed rezoning is to be considered, and at which time the City Council will hear both those who oppose and those who favor the proposal, shall be held at City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on September 16, 2024, at which time the City Council will hear both those who oppose and those who favor the proposal.
- 3. That the City Clerk is hereby authorized and directed to cause notice of said proposal in the accompanying form to be given by publication once, not less than seven (7) days and not more than twenty (20) days before the date of hearing, all as specified in Section 362.3 and Section 414.4 of the Iowa Code.
