WHEREAS, funding is available from S360, PW240406, Operating Budget, Public Works, Street Maintenance for a total estimated annual amount of \$108,000.00; and

WHEREAS, the Procurement Administrator, and Public Works Department recommends approval of the contract award to MB Lawn Care for Right-of-Way Streetscape Landscape Maintenance Services.
