RESOLUTION APPROVING ADDITIONAL FUNDS IN THE AMOUNT OF \$108,460.28 TO THE CURRENT CISCO DNA CENTER ENTERPRISE LICENSE AGREEMENT FROM HEARTLAND BUSINESS SYSTEMS PURSUANT TO THE CURRENT CISCO ENTERPRISE AGREEMENT AND THE STATE OF IOWA CONTRACT #21306

WHEREAS, on March 21, 2022, by Roll Call #22-0449, the City Council approved the purchase of Cisco DNA Software Suites for a use term of five (5) years pursuant to the Cisco Enterprise Agreement from Heartland Business Systems (Peter Helander, President, 108 3rd St, Suite 300, Des Moines, IA 50309) (“Cisco Enterprise Agreement”) for the total amount of \$594,813.41 and utilizing the State of Iowa purchasing contract number 21306; and

WHEREAS, the Information Technology Department has requested the Finance Department’s Procurement Division to issue a change order to the Cisco Enterprise Agreement to allow for additional purchase of Cisco DNA Software Suites required to meet City needs; and

WHEREAS, additional spending in the amount of \$108,460.28 is anticipated for fiscal year 2025 and subsequent renewal periods due to newly implemented devices allowing the City to continue support and maintenance on existing and new wired and wireless software licenses that are needed to operate the City's wired and wireless networks; and

WHEREAS, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance, and Section 2-726(m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, funding for said purchase is available from CIP FY2025, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 26.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the change order allowing an additional expenditure of \$108,460.28 annually for duration of the Cisco Enterprise Agreement with Heartland Business Systems, to be used for the purchase of Cisco DNA Software Suites for use by the Information Technology Department as described above, is hereby approved.
