APPROVING AND AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH NORFOLK SOUTHERN RAILWAY COMPANY FOR THE SOUTHEAST CONNECTOR PROJECT, FROM SE 30th STREET TO US HIGHWAY 65 AT AN ESTIMATED COST OF \$1,316,154

WHEREAS, the Southeast Connector – SE 30th Street to U.S. Highway 65 project will require construction across/adjacent to the Norfolk Southern Railway Company’s facilities; and

WHEREAS, an agreement will allow the City of Des Moines to enter the railway’s right-of-way for renewal of an existing at-grade crossing at SE 30th Street and CB & Q Street, renewal of at-grade crossing at Vandalia Road on the east side of SE 43rd Street, and renewal of the existing flood control closure structure and associated levee north of Vandalia Road.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the agreement between the City of Des Moines and Norfolk Southern Railway Company, 650 West Peachtree Street NW, Box 45, Atlanta, Georgia 30308 at an estimated cost of \$1,316,154, is hereby approved.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Agreement for and on behalf of the City of Des Moines, Iowa.

BE IT FURTHER RESOLVED: That the Engineering Department is authorized to administer the terms specified in the Agreement and make payments in accordance with the Agreement.
