APPROVING RENEWAL OF AGREEMENT FOR PAY-BY-CELL APPLICATION SERVICES FOR MULTI-SPACE PARKING METER SYSTEM WITH PARKMOBILE, LLC

WHEREAS, on August 24, 2020, the Procurement Division issued a Request for Proposals (N21-33) for Pay-By-Cell Application for a Multi-Space Parking Meter (MSM) System that would be compatible with the City's selected MSM equipment and software system, including the Pay-By-Cell application software and software hosting and maintenance, and City staff operations training, to twelve potential proposers and received three proposals in response; and

WHEREAS, on October 4, 2021, by Roll Call No. 21-1485, the City Council approved and accepted the proposal submitted by ParkMobile, LLC, and further approved an Agreement for Pay-By-Cell Application Services for Multi-Space Parking Meter System Between City of Des Moines, Iowa and ParkMobile, LLC, at no cost to the City in consideration of a \$0.25 charge per transaction to users through September 30, 2024; and

WHEREAS, the Agreement provided the option to extend for one additional 3-year term at the City's discretion; and

WHEREAS, the City Manager and City Traffic Engineer recommend approval of the additional three-year renewal term to extend the Agreement through September 30, 2027, with fees remaining the same for the end user and at no cost to the City during the renewal term.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the option to extend the above-described Agreement by and between the City of Des Moines, Iowa and Park Mobile, LLC is hereby approved, and the City Traffic Engineer and designee are authorized to administer said Agreement during the renewal term.


