## APPROVAL OF THE 2024 CONTINUUM OF CARE (COC) GRANT PROGRAM COMPETITIVE APPLICATION, INCLUDING NONCOMPETITIVE AWARD OF YOUTH HOMELESS DEMONSTRATION PROGRAM RENEWAL AND REPLACEMENT GRANTS, TO THE US DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, each year, the Department of Housing and Urban Development (HUD) releases a notification of funding for the Continuum of Care Program which provides funding for efforts by community partners to quickly re-house homeless persons, minimize trauma and dislocation caused by homelessness, to promote access to programs, and to optimize self-sufficiency among those experiencing homelessness; and

**WHEREAS**, Notice of Funding Opportunity (NOFO) for Continuum of Care (CoC) grant was published in the Federal Register on or about July 31, 2024 and applications for funding are due October 30, 2024; and

WHEREAS, the City and Homeward, formerly known as the Polk County Continuum of Care, are preparing an application for \$6,410,648 to be submitted to HUD for approval; and

WHEREAS, of the requested amount, \$5,151,739 is primarily for established programs renewing their funding allocation; \$972,719 is funding allocated by the Youth Homelessness Demonstration Project; and \$286,190 is for a CoC Planning Grant; and

WHEREAS, each year, Homeward, in partnership with the City, facilitates a local competitive grant review process where service providers working with homeless or persons at risk of homelessness submit proposals for funding renewal or new programs; and

WHEREAS, at its meeting on September 23, 2024, the Homeward Board received and recommended approval of Homeward's Grant Committee's recommendations for the 2024 CoC grant application; and

WHEREAS, the application is based upon Homeward's and the City's strategy to address homelessness in Polk County, whereby CoC funds would provide needed services to homeless persons in Des Moines and throughout Polk County and address high priority service gaps within the parameters of the priorities and procedures recommended by the Homeward Board.

**NOW, THEREFORE BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the above referenced CoC program application and certifications thereto are hereby approved and ratified, and the City Manager or his designee is hereby directed to execute any necessary documents and submit the application to HUD.
