RESOLUTION HOLDING PUBLIC HEARING REGARDING REQUEST FROM MEASURED 3708 SE 14TH, LLC (OWNER), REPRESENTED BY GREG DANIELSON (OFFICER), REGARDING PROPERTY IN THE VICINITY OF 3710 SOUTHEAST 14TH STREET TO AMEND PLANDSM TO REVISE THE FUTURE LAND USE DESIGNATION FROM MEDIUM DENSITY RESIDENTIAL TO HIGH DENSITY RESIDENTIAL

WHEREAS, the City Plan and Zoning Commission has advised that at a public hearing held on October 3, 2024, its members voted 12-0 in support of a motion to recommend APPROVAL of a request from Measured 3708 SE 14th LLC (Owner), represented by Greg Danielson (Officer), to amend the PlanDSM: Creating Our Tomorrow future land use designation from Medium Density Residential to High Density Residential, to allow expansion of the existing multiple-household residential development so that it has a net density greater than 17 dwelling units per acre; and

- 1. Upon due consideration of the facts, and any and all statements of interested persons and arguments of counsel, any objections to the proposed amendment are hereby overruled, and the hearing is closed.
- 2. The proposed amendment to PlanDSM: Creating Our Tomorrow Plan to revise the future land use classification for the Property from Medium Density Residential to High Density Residential is hereby approved.
