## SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY LOCATED WEST OF AND ADJOINING 822 SE 12<sup>TH</sup> STREET TO MICHEAL CORTEZ FOR \$50.00

WHEREAS, on August 20, 1979, by Roll Call No. 79-3809, the City Council of the City of Des Moines, Iowa passed Ordinance No. 9621 vacating the all the north-south alley right-of-way in Block 10, Allen's Second Addition, including that portion located west of and adjoining 822 SE 12<sup>th</sup> Street; and

WHEREAS, Micheal Cortez, owner of 822 SE 12th Street, Des Moines, Iowa, has offered to the City of Des Moines ("City") the purchase price of \$50.00 for the purchase of the portion of the vacated alley right-of-way lying west of and adjoining his property at 822 SE 12th Street (hereinafter "Property"), for assemblage with 822 SE 12th Street, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

Legal Description: THE EAST HALF (E 1/2) OF THE VACATED NORTH/SOUTH ALLEY RIGHT OF WAY LYING WESTERLY OF AND ADJOINING LOT 6, BLOCK 10, ALLEN'S SECOND ADDITION TO DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 560 SQUARE FEET.
