REPROGRAMMING OF UNSPENT COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS, TO BE INCLUDED IN THE 2024 ANNUAL ACTION PLAN AS PART OF THE 2020-2024 CONSOLIDATED PLAN UNDER THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on November 4, 2019, by Roll Call No. 19-1792, the City Council held a public hearing regarding the proposed 2020-2024 Consolidated Plan, which outlines the City’s five-year strategy for use of its entitlement funds such as Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) Program, and Emergency Solutions Grant (ESG) from the U.S. Department of Housing and Urban Development (HUD), and authorized the City Manager to submit the 2020-2024 Consolidated Plan to HUD; and

WHEREAS, on November 6, 2023, by Roll Call No. 23-1577, the City Council held a public hearing regarding the proposed 2024 Action Plan, as part of the 2020-2024 Consolidated Plan, and authorized and directed the City Manager to submit the 2024 Action Plan with the required SF-424 application forms and required certifications to HUD once the 2024 allocations were known; and

WHEREAS, the City Manager has reviewed unspent CDBG funding and is recommending that these funds be utilized as set out in the attached council communication and simultaneously administered with the proposed 2024 Annual Action Plan activities; and

WHEREAS, the City’s 2024 Annual Action Plan will be updated to include reprogramming of unspent CDBG funds.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Des Moines, Iowa, that the City Manager's recommendations regarding the utilization of unspent prior years CDBG funding as set out in Council Communication No. 24- 473 are hereby approved.
