AUTHORIZING CITY ENGINEER TO SIGN LETTER OF NO-OBJECTION, WITH STATED QUALIFICATIONS, TO BE SUBMITTED TO THE UNITED STATES ARMY CORPS OF ENGINEERS (USACE) BY ICON WATER TRAILS TO START THE SECTION 408 PERMIT REVIEW FOR THE FLEUR DRIVE SITE

WHEREAS, ICON Water Trails, formerly Central Iowa Water Trails (CIWT) operates as a regional public-private partnership for the purpose of implementing a recreational and dam safety plan for 150 miles of water trails throughout Central Iowa; and

WHEREAS, ICON Water Trails has a plan for Downtown Whitewater Access, which includes a site referenced as the "Fleur Drive Site". This site is located just upstream (west) of the Coleman Bridge to the north of Gray's Lake and will include improvements that will be adjacent to and directly on top of the existing flood control levee; and

WHEREAS, ICON Water Trails is progressing with design at the Fleur Drive Site and will be submitting for United States Army Corps of Engineers (USACE) Section 408 permit review and approval; and


WHEREAS, the Scott Avenue ICON Water Trails project, as proposed, would not achieve the required no-rise certification and would result in an increased water surface elevation of the Des Moines River for the 100-year event between Scott Avenue and SE 6th Street; and

WHEREAS, the Section 408 submittal to the USACE requires a "Letter of No Objection" from the City, as the levee sponsor impacted by the proposed improvements; and

WHEREAS, following City Council approval of the agreement with CIWT, now ICON Water Trails, by Roll Call 20-1829 on November 9, 2020, the CIWT design consultants determined that changes to the City Levee Design would not be required to mitigate the impact of the increased water surface elevation and preserve the City's design requirements in accordance with the United States Army Corps of Engineers ("USACE") and Federal Emergency Management Agency requirements; and

WHEREAS, the responsibility for funding, performing construction, maintenance, repair and operation of the proposed improvements will be handled by ICON Water Trails; and

WHEREAS, the requested "Letter of No Objection" is being authorized, subject to addressing the qualifications set forth and satisfactory resolution of City comments and compliance with the USACE Section 408 approval; and

WHEREAS, qualifications include the need to submit a geotechnical/environmental investigation report, that all costs for redesign and construction if proposed improvements require redesign of the levee system will be borne by ICON Water Trails, and that an agreement will be finalized for the transfer of land, from the City to Polk County, prior to a final "Letter of No Objection" is authorized that will allow ICON Water Trails to construct, operate, repair, and maintain the proposed improvements.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City Engineer, if deemed appropriate in his professional judgment, is authorized to sign and submit a "Letter of No Objection" with stated qualifications on behalf of the City of Des Moines to the United States Army Corps of Engineers for the above-described ICON Water Trails project.
