RESOLUTION APPROVING DOWNTOWN DES MOINES SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT OPERATING AGREEMENT BETWEEN CITY AND DOWNTOWN DES MOINES SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT

WHEREAS, the Downtown Des Moines Self-Supported Municipal Improvement District ("SSMID District") was originally created by the City by Ordinance No. 13,579, passed February 23, 1998 pursuant to the provisions of Chapter 386, Code of Iowa (the "Act") for the purposes of undertaking of actions and the design and construction of any and all improvements authorized by the Act and the performance of administration, redevelopment and revitalization of the SSMID District as authorized by the Act for the benefit of property within the SSMID District; and

WHEREAS, on September 14, 1998, by Roll Call No. 98-2913, the City Council approved a Downtown SSMID operating agreement with Downtown Partnership, Inc.; and

WHEREAS, the SSMID District was continued by the City by Ordinance No. 13,913 passed January 22, 2001, the SSMID District was continued and expanded by Ordinance No. 14,311 passed January 26, 2004, the SSMID District was again expanded by Ordinance 14,540 passed February 6, 2006, the SSMID District was continued by Ordinance No. 14,834 passed February 23, 2009, the SSMID District was further continued by Ordinance 15,213 passed September 23, 2013 pursuant to the provisions of the Act, and the SSMID District was further continued and expanded by Ordinance 16,275 passed August 21, 2023; and

WHEREAS, on March 7, 2005, by Roll Call No. 05-562, on October 12, 2009 by Roll Call No. 09- 1859, on July 28, 2014 by Roll Call No. 14-1183, and on June 24, 2019 by Roll Call No. 19-1044, the City Council approved Downtown SSMID operating agreements with the Downtown Des Moines Self-Supported Municipal Improvement District a/k/a Operation Downtown; and

WHEREAS, following the receipt of the Petition to Continue and Adjust the Boundaries of the Downtown SSMID District ("Petition"), the SSMID District was further continued until June 30, 2024 by Ordinance No. 15,700 passed September 10, 2018 pursuant to the provisions of the Act; and

WHEREAS, the services, improvements and activities to be undertaken within the SSMID District as described in the Petition and in the annual budget of Downtown Des Moines Self-Supported Municipal Improvement District further the general and economic development objectives of the Metro Center Urban Renewal Project and further the Iowa Code Chapter 15A economic development public purposes by assisting in the creation of new jobs

and income in the City and the retention of existing jobs and income in the City that would otherwise be lost; and

WHEREAS, the Petition expresses an intent that the City enter into and continue the operating agreement with Downtown Des Moines Self-Supported Municipal Improvement District to manage and undertake services, improvements and activities described in the Petition and in the annual budget of Downtown Des Moines Self-Supported Municipal Improvement District and to appropriate funds from the Operation Fund and certain funds from the applicable tax increment financing funds to Downtown Des Moines Self-Supported Municipal Improvement District for those purposes; and

WHEREAS, in accordance with the intent of the Petition, a Downtown SSMID Operating Agreement between the City and Downtown Des Moines Self-Supported Municipal Improvement District has been prepared which Agreement provides for a ten-year term extending to June 30, 2034 and is on file in the Office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the City hereby engages Downtown Des Moines Self-Supported Municipal Improvement District to operate, manage and undertake the SSMID services, improvements and activities including implementation of the Operation Downtown project in accordance with the terms of the Operating Agreement

BE IT FURTHER RESOLVED that the Downtown SSMID Operating Agreement between the City and Downtown Des Moines Self-Supported Municipal Improvement District on file in the Office of the City Clerk is hereby approved and the Mayor is authorized and directed to sign the Agreement and the City Clerk is directed to attest to the Mayor's signature.

BE IT FURTHER RESOLVED that the City Manager or his designee is authorized and directed to monitor performance and to perform all City obligations under the Downtown SSMID Operating Agreement.
