## RESOLUTION APPROVING 28E AGREEMENT WITH POLK COUNTY FOR PROVISION OF SERVICES FOR INDIVIDUALS SEEKING SUPPORT AND REFERRALS FOR TREATMENT FOR SUBSTANCE ABUSE AND ACUTE MENTAL HEALTH SERVICES

WHEREAS, the City of Des Moines and Polk county desire to provide a managed physical space for individuals in Polk County, Iowa who are seeking support and referrals for treatment of substance use and acute mental health needs and to jointly provide funding for such services; and

WHEREAS, Polk County, Iowa, acting by and through its Behavioral Health and Disability Services Department (hereinafter "BHDS Dept.") manages the access and delivery of substance abuse and mental health services as the Region Administrator for the Polk County Mental Health and Disability Services Region (hereinafter "Region"); and

WHEREAS, SVdP Substance Abuse Services, LLC (hereafter "SVdP") is an Iowa limited liability company with experience in providing social services directly to clients in the Polk County community; and


**WHEREAS,** Polk County, Iowa will utilize its facilities at 1914 Carpenter Ave., Des Moines, Iowa, as the physical location of the center; and


WHEREAS, SVdP Substance Abuse Services, LLC, through a contract with Polk County shall provide sobering services and community navigation at the center to adult citizen residents of Polk County, Iowa and shall be responsible for facility oversight at 1914 Carpenter Ave. in Des Moines; and

WHEREAS, the City and Polk County have negotiated an agreement pursuant to Chapter 28E of the Iowa Code whereby the City will provide funding to the County to reimburse it for funds expended pursuant to the County's contract with SVdP in an amount not to exceed \$600,000 in its first year with annual increases not to exceed \$25,000 unless otherwise agreed to by the parties. A copy of the Agreement is on file in the office of the City Clerk and available for inspection upon request; and

WHEREAS, by Roll Call number, 24-1292, City Council approved the proposed agreement with the County, however, subsequent to the Council's approval, the County Board of Supervisors approved a slightly modified version of the Agreement which is now on file in the office of the City Clerk and available for inspection upon request.

- 2. The Mayor is authorized and directed to execute such Agreement on behalf of the City and the City Clerk is hereby authorized and directed to acknowledge the Mayor's signature on the Agreement;
- 3. The City Manager or his designee is hereby authorized to administer the Agreement on behalf of the City; and
- 4. The Finance Director or designee is hereby authorized to issue payment in accordance with the Agreement at the direction of the City Manager.


