HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY LOCATED WEST OF AND ADJOINING 822 SE 12TH STREET TO MICHEAL CORTEZ FOR \$50.00

WHEREAS, on August 20, 1979, by Roll Call No. 79-3809, the City Council of the City of Des Moines, Iowa passed Ordinance No. 9621 vacating all of the north-south alley right-of-way in Block 10, Allen's Second Addition, including that portion located west of and adjoining 822 SE 12th Street; and

WHEREAS, Micheal Cortez, owner of 822 SE 12th Street, Des Moines, Iowa, has offered to the City of Des Moines ("City") the purchase price of \$50.00 for the purchase of the portion of the vacated alley right-of-way lying west of and adjoining his property at 822 SE 12th Street (hereinafter "Property"), for assemblage with 822 SE 12th Street, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the Property proposed to be sold, and the City will not be inconvenienced by the sale and conveyance of said Property; and

WHEREAS, on November 18, 2024 by Roll Call No. 24-1566, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on December 9, 2024, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and


WHEREAS, due notice of said proposal to convey the Property was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of the vacated alley right-of-way lying west of and adjoining 822 SE 12th Street, Des Moines, Iowa, as described herein, are hereby overruled and the hearing is closed.

2. There is no public need or benefit for the excess City-owned property proposed to be conveyed, and the public would not be inconvenienced by reason of the conveyance of the vacated alley right-of-way lying west of and adjoining 822 SE 12th Street, Des Moines, Iowa, as legally described, to the grantee, and for the consideration identified below, subject to a reservation of easements therein and said conveyance is hereby approved:


