RESOLUTION APPROVING AN EXTENSION OF AN EXISTING AGREEMENT IN THE AMOUNT OF \$2,211,125 WITH POTENTIAL INFLATION INCREASE, FOR THE PURPOSE OF PUBLIC SAFETY VOICE RADIO COMMUNICATIONS SYSTEM WITH MOTOROLA SOLUTIONS, INC.

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa ("City") shall enter into an extension of the current Agreement with Motorola Solutions, Inc. in the amount of \$2,211,125 with a potential inflation increase (the "Agreement") for the purpose of providing funds for the purchase of providing maintenance to the existing public safety voice radio communications system for years 4-10 of the current Agreement; and

WHEREAS, on February 18, 2018, a "Request for Proposal for Public Safety Voice Radio Communications System" No. V18-049 was issued by the Procurement Division of the Finance Department; and

WHEREAS, on September 24, 2018, Roll Call #18-1607, the City approved an Agreement in the amount not-to-exceed \$9,600,000 plus \$400,000 in short-term contingency costs for the system implementation and a three-year warranty period to Motorola Solutions, Inc., 500 W Monroe Street, Suite 4400, Chicago, IL 60661, Norbeto Colon, Vice President; and

WHEREAS, the City wishes to extend the Agreement for an additional seven years maintenance in the amount \$2,211,125 with a potential inflation increase; and

WHEREAS, funding is available from the operating budget - radio services internal service fund page 217 in the FY25 budget; and

WHEREAS, a copy of the proposed Amendment 1 which extends the Agreement is on file in the Office of the City Clerk which provides that the City shall pay an additional seven annual payments thereafter totaling a principal of \$2,211,125 with potential inflation increases based on the CPI and the calculation formula in the Amendment for the purchase of maintenance for the existing public safety voice radio communications system for years 4-10; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa as follows:

1. The City hereby takes action to authorize, approve and enter into Amendment 1 with Motorola Solutions, Inc. and all incorporated and ancillary documents and the City Manager is hereby authorized and directed to sign Amendment 1 and all incorporated and ancillary documents thereto as may be required.
