**RESOLUTION APPROVING THE PURCHASE OF MANHOLE AND INTAKE CASTINGS TO REPAIR DAMAGED SEWER INFRASTRUCTURE FROM NEENAH ENTERPRISE INCORPORATED, NOT TO EXCEED \$102,100.00, PER RFB #K23-449**

**WHEREAS**, the Public Works Department’s Sewers Division has requested the Finance Department’s Procurement Division to issue a purchase order for the purchase of manhole and intake castings; and

**WHEREAS**, the Procurement Division solicited bids for the FY2024 manhole and intake castings order by publishing Request for Bid K23-449 on the City’s online bid procurement system with one hundred twenty-three (123) potential bidders and two (2) bids received; and

**WHEREAS**, the resulting contract in the amount of \$93,590.00 was awarded to the lowest responsive, responsible bidder, Neenah Enterprise Incorporated, 2121 Brooks Ave., Neenah, WI, 54956; and

**WHEREAS**, per its terms, the contract has been renewed for the FY2025 manhole and intake castings order, and also in accordance with contract terms, the vendor has requested a price increase to \$102,100.00 due to increased material costs; and

**WHEREAS**, funding is available from 2024-2025 Operating Budget, Page 206, Public Works Department, Des Moines Sanitary Sewer Maintenance, E101 PW247411, Sanitary Sewer Operations Fund in an amount not to exceed \$102,120.00.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that the purchase of manhole and intake castings from Neenah Enterprise Incorporated in an amount not to exceed \$102,100.00 pursuant to the general terms and conditions of RFB K23-449 and resulting contract, is hereby approved.
