SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY ADJOINING 926 40th PLACE AND 925 41ST STREET TO CAPITAL HOMES II, L.L.C. D/B/A CUTLER CONSTRUCTION COMPANY AND CINDY L. FITCH AND PAUL E. FINCH

WHEREAS, on October 6, 1986, by Roll Call No. 4760, the City Council of the City of Des Moines, Iowa passed Ordinance No. 10,877 vacating the north/south alley right-ot-way lying east of and adjoining Lots 17 through 23, Campbell Place, including that portion of alley right-of-way lying west of and adjoining 926 40th Place and lying east of and adjoining 925 41st Street, subject to the reservation of easements for public utilities then in place with right of entry for servicing same; and

WHEREAS, Capital Homes II, L.L.C. d/b/a Cutler Construction Company has offered to the City of Des Moines, Iowa ("City") the purchase price of \$25.00 for the purchase of the east half of the vacated north/south alley right-of-way located west of and adjoining 926 40th Place, and Cindy L. Finch and Paul E. Finch have offered to the City the purchase price of \$25.00 for the west half of the vacated north/south alley right-of-way located east of and adjoining 925 41st Street (hereinafter collectively "Property"), for incorporation into their adjoining properties for expanded side yard, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be conveyed, and the City will not be inconvenienced by the conveyance of said Property.
