**SET HEARING FOR APPROVAL OF CONVEYANCE OF FLOOD PROTECTION LEVEE EASEMENTS FOR RELOCATION OF A PORTION OF THE SOUTHEAST DES MOINES LEVEE SYSTEM, AS REQUIRED BY THE SOUTHEAST CONNECTOR – SE 30TH STREET TO U.S. HIGHWAY 65 PROJECT, TO THE UNITED STATES OF AMERICA, ACTING BY AND THROUGH THE SECRETARY OF THE ARMY**

**WHEREAS**, on June 8, 2020, by Roll Call No. 20-0956, the City Council of the City of Des Moines, Iowa authorized acquisition of the necessary property interests, including agricultural land, for the Southeast Connector – SE 30<sup>th</sup> Street to U.S. Highway 65 Project (“Project”) by gift, negotiation, or eminent domain; and

**WHEREAS**, as part of the Project, a portion of the Southeast Des Moines Levee System (“Levee”) will be relocated; and

**WHEREAS**, the City acquired Permanent Easements for Flood Protection Levee (“Easements”) for relocation of the Levee from two property owners as part of the Project. The City’s interest in these Easements need to be quit claimed to the United States of America, acting by and through the Secretary of the Army for no consideration in accordance with Iowa Code Section 364.7(3) for the public purpose of relocation of a portion of the Levee, subject to reservation of the rights to allow the City access to construct the Project which reservation shall terminate upon the acceptance of the Project as complete by the City Council; and

**WHEREAS**, a portion of the relocated Levee is located on City-owned property located east of SE 42<sup>nd</sup> Street, and will require the City to convey a Permanent Easement for Flood Protection Levee to the United States of America, acting by and through the Secretary of the Army for no consideration in accordance with Iowa Code Section 364.7(3) for the public purpose of relocation of a portion of the Levee, subject to reservation of the rights to allow the City access to construct the Project which reservation shall terminate upon the acceptance of the Project as complete by the City; and

**WHEREAS**, there is no known current or future public need or benefit for the City Property proposed to be conveyed, and the City will not be inconvenienced by the conveyance of said Easements.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to convey by Quit Claim two Permanent Easements for Flood Protection Levee acquired by the City for the public purpose of relocation of a portion of the Southeast Des Moines Levee System for the Southeast Connector – SE 30<sup>th</sup> Street to U.S. Highway 65 Project to the United States of America, as legally described, to the United States of America, acting by and through the Secretary of the Army for no consideration in accordance with Iowa Code Section 364.7(3) subject to reservation of the rights to allow the City access to construct the Project which reservation shall terminate upon the acceptance of the Project as complete by the City. The Permanent Easements for Flood Protection Levee to be conveyed are described as follows:


