RESOLUTION APPROVING THE PURCHASE OF TRAFFIC PAINT FROM ENNIS-FLINT INC., AND APPROVING USE OF IOWA DEPARTMENT OF TRANSPORTATION CONTRACT #2024-8346

WHEREAS, the Traffic and Transportation Division of the Engineering Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of Traffic Paint; and

WHEREAS, the Traffic Paint is being procured through the competitive bid process using the State of Iowa Department of Transportation (IDOT) purchasing contract number 2024-8346; and

WHEREAS, Des Moines Municipal Code Section 2-726(b)(18) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Transportation (IDOT) without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Traffic Paint is being purchased from Ennis-Flint Inc., 4161 Piedmont Parkway, Suite 370, Greensboro, NC 27410, in the amount of \$125,000.00 utilizing the State of Iowa Department of Transportation (IDOT) purchasing contract number 2024-8346; and

WHEREAS, funding is available from 2024-25 Operating Budget, Page 72, Engineering Department, T&T - Sign, Painting, Signal and Lighting, EG062080, Road Use Tax Fund.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves the purchase of Traffic Paint from Ennis-Flint Inc., in the total amount of \$125,000.00 using State of Iowa Department of Transportation (IDOT) purchasing contract number 2024-8346, and directs the Finance Department, Procurement Division to issue a purchase order for said goods and at said total amount pursuant to the terms of said IDOT contract.
