APPROVING THE PURCHASE OF AUTO BODY REPAIR SERVICES FOR VARIOUS CITY DEPARTMENTS FROM STEW HANSEN DODGE CITY FOR AN ADDITIONAL \$150,000 FOR FISCAL YEAR 2025 AND AUTHORIZING RENEWAL OF AGREEMENT FOR FISCAL YEAR 2026

WHEREAS, the Department of Finance, Procurement Division entered into an annual blanket purchase for purchase of autobody repair services including labor and parts for the repair by various City Departments for Fiscal Year 2026 with Stew Hansen Dodge City, 12103 Hickman Road, Des Moines, IA 50323 (Dan Boettcher, General Manager), utilizing the State of Iowa (DAS) Master Agreement 22044C Purchasing Contract No. 24579, originally approved on July 15, 2024 by Roll Call No. 24-0987 (the "Agreement"); and,

WHEREAS, whereas the Finance Department requests additional funding to continue purchasing autobody repair services pursuant to the Agreement for Fiscal Year 2026; and,

WHEREAS, the Finance Department requests that the City Manager be authorized to extend the Agreement for one year pursuant to its terms, thus covering Fiscal Year 2027; and,

WHEREAS, funding is available from Fiscal Year 2026 Operating Budget, Fleet Service Maintenance, I010 FN024020, Equipment Maintenance Center Fund, page 88; and,

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, approves the increase of \$150,000 in Auto Body Repair Services from Stew Hansen Dodge City using the Agreement. The Finance Department is hereby directed to proceed with the issuance of a blanket purchase order for Fiscal Year 2026.
