## APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, STAR LOFTS, BETWEEN CAPITAL HOMES II, LLC DBA CUTLER CONSTRUCTION, LLC AND CUTLER DEVELOPMENT, LLC

WHEREAS, on September 16, 2024 under Roll Call No. 24-1221, the City Council approved a private construction contract in the amount of \$40,000.00, between Capital Homes II, LLC DBA Cutler Construction, LLC, Peter Cutler, Owner, 120 5th St, Suite C, West Des Moines, IA, 50265 as Contractor, and Cutler Development, LLC, Scott Cutler, Owner, 1307 50th St, West Des Moines, IA, 50265 as Owner, for construction of Paving Improvements described as Paving Improvements to serve the Star Lofts at 2701 Ingersoll Avenue as shown on Plan File Number 650-182/185, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
