## APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, GRAY'S STATION PLAT 5, BETWEEN ALLIANCE CONSTRUCTION GROUP, LLC AND HRC NFS I, LLC

WHEREAS, on July 17, 2023 under Roll Call No. 23-0974, the City Council approved a private construction contract in the amount of \$525,908.00, between Alliance Construction Group, LLC, Dustin Jones, President, 9400 Plum Drive, Suite 100, Urbandale, IA, 50322 as Contractor, and HRC NFS I, LLC, Rick Tollackson, President and CEO, 6900 Westown Parkway, West Des Moines, IA, 50266, as Owner, for construction of Paving Improvements described as Paving Improvements to serve the Gray's Station Plat 5 development in the vicinity of SW 12th Street and Grays Parkway as shown on Plan File Number 655-097/137, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$525,908.00, which have been constructed in substantial compliance with the contract documents between Alliance Construction Group, LLC and HRC NFS I, LLC, which were approved under Roll Call No. 23-0974, dated July 17, 2023, be received and filed; and that completion of said Paving Improvements described as Paving Improvements to serve the Gray's Station Plat 5 development in the vicinity of SW 12th Street and Grays Parkway as shown on Plan File Number 655-097/137, is hereby acknowledged and that said Paving Improvements are hereby accepted.
