APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, SOUTH UNION ELEMENTARY, BETWEEN TK CONCRETE, INC. AND DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT

WHEREAS, on May 22, 2023 under Roll Call No. 23-0703, the City Council approved a private construction contract in the amount of \$130,365.00, between TK Concrete, Inc., Tony J. Ver Meer, President, 1608 Fifield Road, Pella, IA, 50219, as Contractor, and Des Moines Independent Community School District, Ian Roberts, Superintendent, 1917 Dean Avenue, Des Moines, IA, 50316, as Owner, for construction of Paving Improvements described as Paving Improvements to serve South Union Elementary located at 4201 South Union Street, as shown on Plan File Numbers 646-190/196, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$130,365.00, which have been constructed in substantial compliance with the contract documents between TK Concrete, Inc. and Des Moines Independent Community School District, which were approved under Roll Call No. 23-0703, dated May 22, 2023, be received and filed; and that completion of said Paving Improvements described as Paving Improvements to serve South Union Elementary located at 4201 South Union Street, as shown on Plan File Numbers 646-190/196, is hereby acknowledged and that said Paving Improvements are hereby accepted.
