APPROVING COMPLETION AND ACCEPTANCE OF THE SANITARY SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, GRAY'S STATION PLAT 5, BETWEEN MCANINCH CORPORATION AND HRC NFS I, LLC

WHEREAS, on July 17, 2023 under Roll Call No. 23-0975, the City Council approved a private construction contract in the amount of \$447,987.00, between McAninch Corporation, Douglas D. McAninch, President/CEO, 100 E. Grand Avenue, Suite 350, Des Moines, IA, 50309 as Contractor, and HRC NFS I, LLC, Rick Tollackson, President and CEO, 6900 Westown Parkway, West Des Moines, IA, 50266, as Owner, for construction of Sanitary Sewer Improvements described as Sanitary Sewer Improvements to serve Gray's Station Plat 5, located in the vicinity of the intersection of Murphy Street and SW 13th Street as shown on Plan File Numbers 655-097/137, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Sanitary Sewer Improvements in the amount of \$447,987.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and HRC NFS I, LLC, which were approved under Roll Call No. 23-0975, dated July 17, 2023, be received and filed; and that completion of said Sanitary Sewer Improvements described as Sanitary Sewer Improvements to serve Gray's Station Plat 5, located in the vicinity of the intersection of Murphy Street and SW 13th Street as shown on Plan File Numbers 655-097/137, is hereby acknowledged and that said Sanitary Sewer Improvements are hereby accepted.
