**RESOLUTION SETTING DATE OF HEARING TO CONSIDER THE
RECOMMENDED CAPITAL IMPROVEMENT PROGRAM PLAN FOR FISCAL
YEARS 2025-2026 THROUGH 2028-2029**

WHEREAS, the City Manager has submitted a revised recommended Capital Improvement Program (CIP) Plan which includes the Capital Improvement Plans for fiscal years 2025-2026 through 2028-2029 and includes the Capital Improvement Budgets for fiscal year 2024-2025, as amended; and,

WHEREAS, Section 384.15(3), Code of Iowa, requires a public hearing on the recommended Capital Improvement Program Plan prior to its adoption.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Clerk is hereby directed to immediately make available a sufficient number of copies of the recommended Capital Improvement Program Plan to meet the request of taxpayers and organizations and to have the copies of the recommended Capital Improvement Program Plan available for distribution and pickup at the City Hall Offices of the Mayor and City Clerk and at the City libraries.

2. The public hearing on the prepared Capital Improvement Program Plan is hereby fixed and set for the 7th day of April, 2025 at 5:00 p.m. in the Council Chambers in City Hall, Des Moines, Iowa, at which time any resident or taxpayer of the City may be heard for or against the prepared Capital Improvement Program Plan.

3. The City Clerk be and is hereby authorized and directed to execute and publish notice of said hearing in the attached form in the Des Moines Register, a newspaper of general circulation in the City of Des Moines, Polk County, Iowa, in accordance with Iowa Code Section 362.3.
