**APPROVING GC25 PUBLIC ART GRANT AGREEMENT
WITH BRAVO GREATER DES MOINES FOR \$22,750.00 OF GRANT FUNDING
FOR PIONEER COLUMBUS COMMUNITY RECREATION CENTER MURAL PROJECT**

WHEREAS, the City of Des Moines owns real property commonly referred to as the Pioneer Columbus Community Recreation Center and locally known as 2100 SE 5th Street, Des Moines, Iowa, upon which the City intends install and maintain for a defined and agreed upon duration, a mural on the exterior of the building (the "Project") for the benefit and enjoyment of the residents of the City, subject to availability of funds; and

WHEREAS, BRAVO Greater Des Moines, a non-profit organization, has selected the City of Des Moines to receive a \$22,750.00 grant for use for the Project and has requested that the City approve and comply with a GC25 Public Art Grant Agreement ("Agreement"), in form on file in the office of the City Clerk, pursuant to which Agreement BRAVO will reimburse the City for funds used to pay the artist team selected following an RFP and final design selection process for installation of the mural as part of the Project; and

WHEREAS, said Agreement requires the City to indemnify BRAVO against claims related to the Project and/or to the Agreement and requires the City to repay grant funds to BRAVO in the event of City breach of the Agreement; and

WHEREAS, the granted funds received by the City pursuant to the Agreement will be deposited into fiscal year 2025 Adopted Capital Improvement Plan, PK143, Park Building Improvements, page 67.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the GC25 Public Art Grant Agreement between BRAVO Greater Des Moines and the City of Des Moines, in form on file in the City Clerk's Office, is hereby approved, and the City Parks and Recreation Department Director is hereby authorized and directed to execute and administer said Grant Agreement on behalf of the City.
