SET HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF STREET RIGHT-OF-WAY ADJOINING 100 28TH STREET AND GEOPARCEL 7824-07-280-002 AND CONVEYANCE TO CORNERSTONE DEVELOPERS, L.L.C. FOR \$1,000.00

WHEREAS, Cornerstone Developers, L.L.C., an Iowa limited liability company, represented by Julie Klein, the owner of Geoparcel 7824-07-280-002, has requested that the City of Des Moines, Iowa ("City") vacate the platted street right-of-way adjoining 100 28th Street and Geoparcel 7824-07-280-002, which request was not presented to the City's Plan and Zoning Commission for review and has instead been determined by the City Traffic Engineer to have no significant impact upon the public use of the right-of-way, in accordance with Municipal Code 102-286(b); and

WHEREAS, Cornerstone Developers, L.L.C., has offered to the City of Des Moines ("City") the purchase price of \$1,000.00 for the purchase of the vacated street right-of-way adjoining 100 28th Street and Geoparcel 7824-07-280-002, Des Moines, Iowa (hereinafter "Property") for assemblage with their adjoining property, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the street right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating the street right-of-way adjoining 100 28th Street and Geoparcel 7824-07-280-002, Des Moines, Iowa, legally described as follows, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated:
