**WHEREAS**, on September 11, 2023, by Roll Call No. 23-1275, the City Council of the City of Des Moines, Iowa, approved the City-initiated request to amend the the PlanDSM Creating Our Tomorrow Plan to adopt ReflectDSM: Honoring All Des Moines Histories (Historic Preservation Plan) and incorporate as an element; and

WHEREAS, on August 19, 2024, by Roll Call No. 24-1153, the City Council of the City of Des Moines, Iowa, approved the City's submittal of Fiscal Year 2025 State of Iowa Certified Local Government (CLG) grant application to assist with consulting services for the development of a work program and public engagement strategy for conducting a City-wide historic survey; and

**WHEREAS**, City staff have been notified of the City's award of the CLG Grant in the amount of \$20,000 based on said application; and

**WHEREAS**, as a condition of accepting such CLG grant award, the City must enter into a Certified Local Government Program Grant Agreement with the Iowa Economic Development Authority, which requires a match of \$20,000 from 2024-2025 CIP, Page 38, Housing Study and PlanDSM Update, MS028.

**NOW THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, as follows:

That the Mayor is hereby authorized and directed to sign the Certified Local Government Program Grant Agreement, and, in addition, the City's Development Services Director or his designee is hereby directed to execute any electronic signature required to effectuate the City's approval and administration of said grant agreement, subject only to review of the City's Legal Department.
