

**Roll Call Number**25-0563**Agenda Item Number**13**Date** April 21, 2025**RESOLUTION AUTHORIZING RELEASE OF SPECIAL ASSESSMENTS FOR 1904 11th STREET ACQUIRED THROUGH THE TAX SALE CERTIFICATE PROCESS**

WHEREAS, Iowa Code Section 446.19A permits cities to acquire tax sale certificates for abandoned property assessed as residential property or as commercial multifamily property or vacant residential lots at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the certificate holder the amount then due to redeem the certificate, and to further assign said certificates, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings and lots; and

WHEREAS, on June 3, 2024, by Roll Call No. 24-0802, the City Council approved acquisition of the tax sale certificate for the vacant and abandoned properties locally known as 1904 11th Street, Des Moines, Iowa ("Property") ; and

WHEREAS, on February 25, 2025, the City of Des Moines requested and was issued the tax sale deeds for the Property by the Polk County Treasurer; and

WHEREAS, Neighborhood Services is in the process of identifying a path for redevelopment or rehabilitation and the special assessments against the Property have been identified as an encumbrance to redevelopment for housing; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. All special assessments levied by the City and pending against the Property shall be deemed released. This shall include assessments listed below and any other City of Des Moines special assessments incurred by the property and tracked by the Polk County Treasurer's Office prior to the date of this roll call.
