RESOLUTION APPROVING MICROSOFT ENTERPRISE ENROLLMENT AGREEMENT AND PROCUREMENT OF MICROSOFT ENTERPRISE SERVICES FROM INSIGHT PUBLIC SECTOR FOR \$2,528,762.34 PER OMNIA CONTRACT #23-6692-03 AND CITY SHORT FORM #K24-449

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for Microsoft Enterprise software support services; and

WHEREAS, the Procurement Administrator has determined that the requested Microsoft Enterprise software support services have been competitively procured and are available from Insight Public Sectors, Inc. (Joyce Mullen, President and CEO, 910 W. Carver Rd., Tempe, AZ 85284) through Omnia Partners using Tempe, Arizona Contract #23-6692-03; and

WHEREAS, Des Moines Municipal Code Section 2-726(b)(20) provides for the procurement of goods or services that have been competitively established through cooperative group contracting consortiums for State government departments, institutions, agencies and political subdivisions, such as Omnia Partners through Tempe, Arizona, without conforming to the competitive bidding requirements of the Procurement Division; and

WHEREAS, the Microsoft Enterprise software support services will be purchased from Insight Public Sector, Inc. for a three-year period for the total amount of \$2,528,762.34 using Omnia Partners Contract #23-6692-03; and

WHEREAS, said purchase requires an updated Microsoft Enterprise Enrollment Agreement between the City and Microsoft Corporation, in substantially the form on file in the office of the City Clerk, and is further subject to an existing Short Form Agreement – City Contract No. K24-449 between the City and Insight Public Sector, Inc., supplementing said Omnia Partners Contract with terms specific to the City's procurement; and

WHEREAS, annual funding for said purchase is available from Capital Improvement Program (CIP) Fiscal Year (FY) 2025, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 26; CIP FY2025, BL133, C034PK99, City Facility and Armory Replacement, Page 50; FY2025 Adopted Operating Budget, Information Technology Department, Enterprise Application Development, G001, IT152000, page 130.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of Microsoft Enterprise software support services, in a total cost of \$2,528,762.34 for a three-year term from May 1, 2025, to April 30, 2028, pursuant to the Microsoft Enterprise Enrollment Agreement, the general terms and pricing of Omnia Partners Contract #23-6692-03 with Insight Public Sector, Inc., and the existing Short Form Agreement – City Contract No. K24-449 between the City and Insight Public Sector, Inc., is hereby approved.
