**RESOLUTION HOLDING PUBLIC HEARING ON THE PROPOSED  
SIXTEENTH AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE  
SE AGRIBUSINESS URBAN RENEWAL AREA**

WHEREAS, on January 26, 1998, by Roll Call No. 98-275, the City Council adopted the Urban Renewal Plan for the SE AgriBusiness Urban Renewal Project, and such Plan has been amended fifteen times (the urban renewal plan as amended is hereinafter referred to as the "Plan"); and

WHEREAS, the SE AgriBusiness Urban Renewal Project Area encompasses an irregularly shaped area generally located between S.E. 14th Street and SE 43rd Street, and between Dean Avenue and the Des Moines River; and

WHEREAS, the purpose of the proposed Sixteenth Amendment to the Plan, which is on file and available for inspection in the office of the City Clerk, is to:

1. Amend Appendix A – Approved Economic Development and Redevelopment Activities to approve the acquisition by voluntary sale of approximately 6 acres of land adjacent to SE 36<sup>th</sup> Street, between Vandalia Road and the future SE Connector, and to update the Des Moines Transloading Facility item.
2. Amend Appendix B – Approved Public Improvements, Public Buildings and Street Projects to update the Southeast Ag Land Acquisition Funding item and include the Southeast Ag Land Clean Up and Site Preparation Funding item.
3. Amend Map 6 – Acquisition Parcels, and Map 7 – Disposition Parcels
4. Update *Exhibit A* - Financial Condition Report to reflect the new projects and material amendments to existing projects.

WHEREAS, on March 24, 2025 by Roll Call No. 25-0441, the City Council resolved that a public hearing on the proposed Sixteenth Amendment be held on April 21, 2025, at 5:00 p.m., in the Council Chambers; and

WHEREAS, the Urban Design Review Board reviewed the proposed Sixteenth Amendment at its meeting on April 1, 2025, and voted 7-0 to approve said Amendment; and

WHEREAS, notice of this public hearing was published in the Des Moines Register on April 9, 2025, which notice sets forth the information required by Section 403.5(3) of the Iowa Code; and

WHEREAS, a copy of the Sixteenth Amendment and notice of this hearing was given by ordinary mail to the Des Moines Public School District, Polk County, Des Moines Area Community College, and Des Moines Area Regional Transit Authority, together with notice of a consultation meeting on the Sixteenth Amendment which was held on April 3, 2025; and

WHEREAS, the City has received no requests from the Des Moines Public School District, Polk County, Des Moines Area Community College, or Des Moines Area Regional Transit Authority for any modification of the proposed division of revenue from the tax increment of the Urban Renewal Project Area; and

WHEREAS, the public hearing has now been opened and all persons and organizations desiring to be heard regarding the proposed Sixth Amendment to the Plan have been given the opportunity to be heard.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The public hearing on the proposed Sixteenth Amendment to the Urban Renewal Plan for the SE AgriBusiness Urban Renewal Area is hereby closed.
2. Upon consideration of the recommendations of the Urban Design Review Board and all other recommendations and statements from all other interested parties and organizations, the City Council finds that the Sixteenth Amendment conforms to the PlanDSM: Creating Our Tomorrow plan, as amended, for the development of the City as a whole.
3. The Urban Renewal Plan for the SE AgriBusiness Urban Renewal Area is hereby amended as set forth in the Sixteenth Amendment. The Urban Renewal Plan for the SE AgriBusiness Urban Renewal Project, as amended by the Sixteenth Amendment thereto, is hereafter in full force and effect.
4. The City Clerk is directed to cause the Sixteenth Amendment and a certified copy of this resolution to be recorded in the land records of the Polk County Recorder.
