**RESCIND PREVIOUSLY APPROVED PRIVATE CONSTRUCTION CONTRACT BETWEEN
J & K CONTRACTING, LLC AND NELSON CONSTRUCTION SERVICES, LLC
FOR SANITARY AND STORM SEWER IMPROVEMENTS IN 418 E. 4TH STREET, \$85,605**

WHEREAS, on May 6, 2024, by Roll Call No. 24-0646, the City Council approved a Private Construction Contract in the amount of \$85,605.00 between J & K Contracting, LLC, Jeremy Feldmann, President, 10703 Justin Drive, Urbandale, IA, 50322, as Contractor, and Nelson Construction Services, LLC, Mike Nelson, Owner, 405 6th Avenue, Suite 201, Des Moines, IA, 50309, as Owner, for construction of Sanitary and Storm Sewer Improvements described as Sanitary and Storm Sewer Improvements to serve the new development located at 418 E. 4th Street as shown on Plan File numbers 609-003/006, Activity ID 08-2020-101, and granted permission to the parties to construct said Sanitary Sewer Improvements; and

WHEREAS, Nelson Construction Services, LLC desires to change the contractor for said improvements from J & K Contracting, LLC, Jeremy Feldmann, President, 10703 Justin Drive, Urbandale, IA, 50322, as Contractor, to a contractor to be determined at a later date, due to J & K Contracting, LLC terminating the contract for this project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the City Council hereby rescinds its action on May 6, 2024, by Roll Call No. 24-0646 to approve a Private Construction Contract in the amount \$85,605.00 between J & K Contracting, LLC, Jeremy Feldmann, President, 10703 Justin Drive, Urbandale, IA, 50322, as Contractor, and Nelson Construction Services, LLC, Mike Nelson, Owner, 405 6th Avenue, Suite 201, Des Moines, IA, 50309, as Owner; and directs the City Engineer to return all original contracts and bonds to Nelson Construction Services, LLC
