## ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY TO INSTALL STREETLIGHTS AND PEDESTRIAN LIGHTS FOR E. 4TH STREET RECONSTRUCTION FROM NORTH OF E. MARKET STREET TO E. COURT AVENUE, ESTIMATED AT \$147,552.13

WHEREAS, reconstruction of E. 4<sup>th</sup> Street from E. Martin Luther King Jr. Parkway to E. Market Street requires installing 13 LED streetlights on banner strength poles and 13 LED pedestrian lights on sidewalk side of same poles; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install the streetlights and pedestrian lights on utility poles; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to install the streetlights and pedestrian lights is \$147,552.13; and

WHEREAS, payment may be withheld until completion of the project; and

WHEREAS, the proposal provides that since the estimated cost of construction is over \$100,000, the City is required by tariff to pay actual costs upon completion of the work, which could result in an increase or decrease in the estimated cost of \$147,552.13 to the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the proposal from MidAmerican Energy Company to the City of Des Moines to install 13 LED streetlights on banner strength poles and 13 LED pedestrian lights on sidewalk side of same poles for E. 4<sup>th</sup> Street from E. Martin Luther King Jr. Parkway to E. Market Street, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
- 2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is authorized to administer the terms specified in the proposal.
- 4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for the actual costs upon receipt of an invoice acceptable to the Engineering Department.
