APPROVING TERMINATION AGREEMENT WITH WELLS FARGO FINANCIAL REGARDING THE DEVELOPMENT AGREEMENTS, RESTRICTIVE COVENANTS, AND MINIMUM ASSESSMENT AGREEMENTS FOR THE PROPERTY AT 800 AND 801 WALNUT STREET AND 800 MULBERRY STREET

WHEREAS, the City and Wells Fargo Financial, LLC, an Iowa limited liability company, are parties to two Development Agreements approved by the Des Moines City Council and recorded on January 19, 2001, in Book 8685, Page 487 and December 22, 2003 by Roll Call No. 03-2898, respectively, in the office of the Polk County Recorder (the "Development Agreement"), whereby Developer agreed to construct multiple office buildings, a parking ramp, and provide a certain number of jobs at the real estate locally known as 800 and 801 Walnut St. and 800 Mulberry Street, Des Moines, Iowa (collectively referred to herein as the "Property"), as part of an urban renewal project within the Metro Center Urban Renewal Area; and

WHEREAS, the Developer conveyed to the City the beneficiary interests of two Declarations of Covenants recorded on February 7, 2003 in Book 9620, Page 982 and January 19, 2006 in Book 11489, Page 659, respectively, in the office of the Polk County Recorder (the "Declaration of Covenants"); and

WHEREAS, the Developer and the City entered into two Minimum Assessment Agreements for the Property and recorded at Book 9576, Page 963 and Book 11554, Page 710, respectively, in the Office of the Polk County Recorder (the "Minimum Assessment Agreement"); and

WHEREAS, the City Council previously agreed to terminate the Minimum Assessment Agreement as to some of the property described herein, however, the parties wish to clarify that the Agreement is terminated as to certain additional property as well as that property previously terminated; and

WHEREAS, the parties have previously agreed to allow the Development Agreement and Restrictive Covenants to expire on their own terms and have released each other from any obligation or further performance thereunder; and

WHEREAS, Developer wishes to clear the Property of the obligations imposed on the Property and Developer by the Development Agreements, Restrictive Covenants, and Minimum Assessment Agreement and has accordingly requested that the same be terminated and released; and

WHEREAS, City and Developer have entered into an agreement terminating the Minimum Assessment Agreement, Development Agreements, and Restrictive Covenants, a copy of which is on file in the office of the City Clerk and available for inspection upon request.
