**RESOLUTION APPROVING THE PURCHASE OF PHONE SYSTEM  
IMPLEMENTATION CONSULTING AND PROFESSIONAL SERVICES FROM  
CARRIER ACCESS IT, USING OMNIA AGREEMENT #R200803  
AND CITY OF DES MOINES SHORT-FORM AGREEMENT #K25-336**

**WHEREAS**, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of phone system implementation consulting and professional services to help with the implementation and launch of Microsoft Teams Calling; and

**WHEREAS**, the Procurement Administrator has determined that the requested phone system implementation consulting and professional services have been competitively bid and are available from Carrier Access IT (Chad Kruse, President/CEO; 1275 Northwest 128th Street #210, Clive, IA 50325), an authorized subcontractor of TD SYNnex Corporation (formerly known as SYNnex Corporation), using Omnia Contract #R200803 ("Omnia Agreement"); and

**WHEREAS**, Des Moines Municipal Code Section 2-726(b)(20) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the phone system implementation consulting and professional services are being purchased from Carrier Access IT in an amount not to exceed \$285,000.00; and

**WHEREAS**, funding for said purchase is available from 2025-26 Capital Improvement Program, Enhanced Information and Communication System, MS001, Page 57.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Des Moines, Iowa, that:

1. The purchase of phone system implementation consulting and professional services, in an amount not to exceed \$285,000.00, from Carrier Access IT, an authorized subcontractor of TD SYNnex Corporation, pursuant to the general terms and pricing of Omnia Contract #R200803, is hereby approved.
2. Short-Form Agreement #K25-336 between the City and TD Synnex Corporation supplementing Omnia Contract #R200803, in form on file in the office of the City Clerk, is hereby approved; the Mayor is authorized and directed to execute said Agreement on behalf of the City; and the Information Technology Department Manager and designee are directed to administer said Agreement on behalf of the City.
3. The Information Technology Department Director is authorized to approve and to sign any implementing or license agreements with TD SYNnex Corporation, subject to approval as to form by the Legal Department.
