**ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY  
TO INSTALL STREETLIGHTS FOR THE SOUTHEAST CONNECTOR – SE 30<sup>th</sup> STREET TO  
U.S. HIGHWAY 65 (U.S. 65) PROJECT, ESTIMATED AT \$151,115.81**

WHEREAS, the Southeast Connector – SE 30th Street to U.S. Highway 65 (U.S. 65) project requires installation of streetlights; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install 17 streetlights; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to install the streetlights is estimated at \$151,115.81.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines to install the new LED streetlights for the Southeast Connector – SE 30th Street to U.S. Highway 65 (U.S. 65), a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
2. That the Mayor is hereby authorized and directed to sign the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for the actual costs upon receipt of an invoice acceptable to the Engineering Department.
