COMMUNITY DEVELOPMENT BLOCK GRANT TO PREPARE FOR, PREVENT, AND RESPOND TO CORONAVIRUS (CDBG-CV) FUNDING AGREEMENT WITH THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) FOR SHELTER OPERATIONS

WHEREAS, on March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into Public Law 116-136, which provides additional Community Development Block Grant funding to prepare for, prevent, and respond to coronavirus (CDBG-CV); and

WHEREAS, on April 2, 2020, the U.S. Department of Housing and Urban Development (HUD) allocated the City of Des Moines \$2,231,212 in CDBG-CV round one funds for activities to respond to the public health crisis; and

WHEREAS, on May 11, 2020, HUD announced the availability of a second round of \$1 billion in CDBG-CV funds for states which allows them to fund activities in entitlement areas; and

WHEREAS, HUD allocated \$9,529,120 in CDBG-CV funds to the State of Iowa and to be administered by Iowa Economic Development Authority (IEDA); and

WHEREAS, IEDA chose a methodology for funding entitlement cities based on population and a standard factor and allocated \$2,067,124 CDBG-CV funds to the City of Des Moines; and

WHEREAS, the City expended its initial CDBG-CV allocation from the State and was invited to apply for an additional \$456,000 for local shelter operations; and

WHEREAS, IEDA has approved the City's application for shelter operations and now forwarded a Grant Agreement for \$456,000 of CDBG-CV, as on file with the City Clerk and by this reference made a part hereof.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the above referenced Grant Agreement by and between IEDA and the City of Des Moines, whereby the City will receive CDBG-CV funds totaling \$456,000, is hereby approved.
- 2. That the Mayor is hereby authorized and directed to execute the above referenced Grant Agreement and the City Clerk to attest to her signature.
- 3. That the Neighborhood Services Director and designees are authorized and directed to administer the Grant Agreement in accordance with the funding and programs described in Council Communication No. 25-246.
