RESOLUTION APPROVING THIRD AMENDMENT TO AGREEMENT BETWEEN THE CITY OF DES MOINES AND DOWNTOWN SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT FOR PARK, OPEN SPACE, AND STREETSCAPE MAINTENANCE OF PRINCIPAL RIVERWALK, HANSEN TRIANGLE, WESTERN GATEWAY PARK, EAST LOCUST STREETSCAPE, AND MLK JR. PARKWAY

WHEREAS, on June 24, 2019, by Roll Call #19-1046, the City Council approved Agreement between the City of Des Moines and Downtown Self-Supported Municipal Improvement District for Park, Open Space, and Streetscape Maintenance of Principal Riverwalk, Hansen Triangle, Western Gateway Park, East Locust Streetscape, and MLK Jr. Parkway ("Agreement"), setting forth maintenance services, obligations, and payments by the City and SSMID related to said downtown improvements; and

WHEREAS, on June 17, 2024, by Roll Call #24-0878, the City Council approved the First Amendment to the Agreement extending the Agreement from June 30, 2024 to September 30, 2024, and added an option of a further three-month extension to December 31, 2024 which was exercised by the parties; and

WHEREAS, on November 18, 2024, by Roll Call #24-1578, the City Council approved the Second Amendment to the Agreement extending the Agreement from December 31, 2024 to June 30, 2025; and

WHEREAS, the City and SSMID desire to amend the Agreement to allow for a further extension thereof to September 30, 2025, under the existing terms of the Agreement and with partial quarterly payment to be made by the City in the amount of \$115,680.75.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The Third Amendment to Agreement between the City of Des Moines and Downtown Des Moines Self-Supported Municipal Improvement District for Park, Open Space, and Streetscape Maintenance of Principal Riverwalk, Hansen Triangle, Western Gateway Park, East Locust Streetscape, and MLK Jr. Parkway, is hereby approved in form on file in the office of the City Clerk.
- 2. The City Manager is authorized and directed to sign the Third Amendment on behalf of the City, extending the Agreement through September 30, 2025.
- 3. The Parks and Recreation Department Director is directed to administer and continue negotiations on replacement of said Agreement in accordance with its terms, as amended, and the Finance Department is authorized to make payment of the quarterly amount due under said amended Agreement.
