APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE REQUEST FOR PROPOSAL (RFP) PROCESS FOR GOOD CAUSE AND APPROVING RENEWAL AMENDMENT FOR AUTOMATED TRAFFIC ENFORCEMENT (ATE) SERVICES CONTRACT WITH SENSYS GATSO USA, INC.

WHEREAS, Roll Call No. 10-1169, dated July 12, 2010, approved an RFP Evaluation and Selection Committee's Recommendations for Award of contract for the provision of Automated Electronic Speed and Red Light Enforcement Cameras & Citation Processing Services to GATSO USA, Inc. now operating as SENSYS GATSO USA, INC. and authorizing the Police Department to negotiate and the City Manager to execute, a contract for the provision of the same; and

WHEREAS, the City of Des Moines Police Department withes to utilize the same contract for the same purpose that City staff negotiated with GATSO USA, INC., and amend for a five-year additional term with an optional one-year extension, and reducing the service fees to be paid by the City to GATSO to \$22 per red light citation and \$22 per speed citation; and

WHEREAS, the City Manager recommends that the procurement of Automated Traffic Enforcement (ATE) Services be exempted from the competitive bid requirements for good cause shown, pursuant to section 2-710 (b) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding for said procurement is available from the Police Department operating budget; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, that:

- 1. Good Cause has been shown to exempt the procurement of ATE Services from the City's Procurement Ordinance competitive procurement requirement.
- 2. To the extent determined necessary by the Legal Department and the Police Department, they are hereby authorized and directed to proceed with negotiation of the renewal amendment for ATE Services by and between the City of Des Moines and SENSYS GATSO USA, INC and to administer and monitor said agreement on behalf of the City and the City Manager is authorized to execute any amendments or renewals.
- 3. Following approval as to form by the Legal Department of said Amendment, the City Manager is hereby authorized and directed to execute said document.
