RESOLUTION CLOSING PUBLIC HEARING ON ORDINANCE AMENDING THE FRANCHISE HERETOFORE GRANTED TO IOWA POWER AND LIGHT COMPANY, PREDECESSOR IN INTEREST TO MIDAMERICAN ENERGY COMPANY AND INCREASING THE FRANCHISE FEE PURSUANT TO IOWA CODE SECTIONS 364.2(4)(f) and 384.3A(3)(j).

WHEREAS, pursuant to Ordinance No. 16,134 adopted by the city council on May 15, 2022, the City of Des Moines did extend the franchise previously granted to MidAmerican Energy Company, the successor to Iowa Power and Light Company, for a period of 13 years from June 15, 2022 until June 15, 2035 the right, franchise and privilege to acquire, construct, operate and maintain in the City of Des Moines, Iowa, the necessary facilities for the production, distribution, transmission and sale of electric energy for public and private use; and to use and occupy the public streets, highways, avenues, alleys, bridges and public places for such purposes; providing for the imposition and collection of a franchise fee from its customers in consideration thereof; and prescribing the terms and conditions thereof; and,

WHEREAS, due notice of the hearing was published in the Des Moines Register on July 2, 2025, as provided by law, setting forth the time and place for hearing on the proposed amendment to the electric energy franchise granted to MidAmerican Energy Company; and

WHEREAS, in accordance with the notice those interested in the proposed amendment to the electric energy franchise granted to MidAmerican Energy Company, both for and against, have been given the opportunity to be heard with respect thereto and have presented their views to the City Council; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts, statements of interested persons and arguments of counsel, the objections to the proposed ordinance amending the electric energy franchise granted to MidAmerican Energy Company are hereby overruled, and the hearing is closed.
- 2. It is hereby determined that it would be in the best interests of the City of Des Moines and its residents to amend the electric energy franchise granted to MidAmerican Energy Company to seven and one-half percent (7.5%) of the gross revenue of the Company, minus uncollectible accounts, derived from the distribution, transmission and retail sale of electric energy by the Company to customers within the current or future corporate limits of the city (excluding, however, the sale of electric energy to the city). The franchise fee shall revert to five percent (5%) five years after it is first charges.
- 3. In accordance with Section 364.2(4)(b) of the Iowa Code, the City Council shall dispense with an election to approve of the proposed ordinance amending the electric

energy franchise granted to MidAmerican Energy Company unless a valid petition requesting submission of the proposed ordinance to the voters is accepted for timely filing with the City of Des Moines.

4. Upon final passage by the City Council and publication of the proposed ordinance amending the electric energy franchise granted to MidAmerican Energy Company, the Mayor shall promptly notify the State of Iowa Director of Revenue of such action.
