SET HEARING FOR VACATION OF MULTIPLE SEGMENTS OF STREET AND ALLEY RIGHT-OF-WAY IN THE VICINITY OF 201 SE 7TH STREET FOR CITY STORM WATER AND PARK IMPROVEMENTS

WHEREAS, on July 14, 2025, by Roll Call No. 25-0971, the City Council of the City of Des Moines, Iowa voted to receive and file a recommendation from the City Plan and Zoning Commission to approve a City initiated request to vacate multiple segments of street and alley right-of-way in the vicinity of 201 Southeast 7th Street ("Property") to allow for incorporation into a naturalized detention park on the eastern portion of the Market District; and

WHEREAS, there is no known current or future public need or benefit for the right-of-way proposed to be vacated, and the City will not be inconvenienced by the vacation of said right-of-way, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating multiple segments of street and alley right-of-way in the vicinity of 201 SE 7th Street, Des Moines, Iowa, legally described as follows, subject to the reservation of any necessary easements for all existing utilities in place until such time as they may be abandoned or relocated:


